## ORDER



**WHEREAS** during the last few years this office has been working on updating the records related to the Forest Rest Houses and Eco-tourism Centres and **WHEREAS** most of the work have already been completed and a publication is planned to be brought out regarding the eco-tourism facilities and Rest Houses of entire state and **WHEREAS** the Forest Department has given emphasis on bringing the entire eco-tourism management under a single roof including the eco-tourism centres run by West Bengal Forest Devp. Corpn. Ltd.
